SUBJECT: Downtown Burbank Partnership (PBID) Meeting – July 9, 2020

- Staff announced that PBID marketing firm Anyone Collective is working on three
 marketing campaigns that will be debuted on social media over the next few weeks.
 The first campaign focuses on the Downtown Burbank Farmer's Market, while the
 other two campaigns will focus on family friendly events and outdoor dining
 respectively.
- StreetPlus provided an update on the PBID's Hospitality and Social Outreach program. Staff is currently working to implement a staggered schedule to allow for longer coverage by a singular ambassador in addition to on-site check-ins from Metrolink's 24-hour staff. This will help to keep extra eyes and ears on Downtown while San Fernando is closed to traffic, and as businesses begin to reopen for full service.
- Staff presented a holiday décor proposal from The Christmas Light Guy Co. for review. The Board approved a 2-year contract with The Christmas Light Guy Co. for \$100,800 annually with option to extend for a third year of service.
- The PBID approved an allocation of \$30,000 for the creation of five communal outdoor dining parklets along San Fernando Blvd. Funds will cover the purchase of materials, permitting, installation, and signage for the outdoor dining parklets. The parklets will be communal, and are not intended to serve any singular business. They cannot be reserved for use by businesses, and neither table service nor alcoholic drinks are permitted. The areas will be maintained by StreetPlus staff and receive daily service from Stay Green.
