City of Burbank Investment Portfolio Report for March 2020 Dated April 27, 2020

This report fulfills City, Youth Endowment Services Fund, Parking Authority, Public Financing Authority, Successor Agency to the Redevelopment Agency and Housing Authority resolutions.

CITY PORTFOLIO OVERVIEW

The City must maintain \$87 million in liquidity at all times (maturities within one year plus real estate taxes due from the County in April and December) to meet our projected budgeted expenditures. We currently have \$261 million in liquidity, with \$150 million in our account at the Local Agency Investment Fund (LAIF), \$68 million in investments maturing within a year and \$43 million in real estate taxes due in April and December. Higher liquidity levels continue to be maintained in anticipation of future cash outflows.

The City Investment Pool ended March at \$470 million, down from February's balance of \$492 million. Market value increased from 101.11% in February to 101.37% in March. The weighted average yield of the portfolio at the end of the month is 2.16% and the total rate of return fiscal year-to-date is 2.31%.

Credit News:

On April 23, S&P's downgraded The Walt Disney Company from A to A- stating that "operating performance for Burbank, Calif.-based The Walt Disney Co. continues to be negatively affected across most of its businesses by COVID-19. Most importantly, its theme parks and film and TV studios remain closed by government-mandated social distancing orders and it's unclear when they will be allowed to reopen."

On April 16, S&P's also placed The Walt Disney Company under negative watch saying "we believe Disney's businesses that require social contact may take much longer to return to normalcy than originally anticipated as a result of continued implications from the COVID-19 pandemic."

On March 31, S&P's affirmed The Estee Lauder Co. Inc.'s ratings at A+ while revising its outlook to negative stating that "store closures, global travel restrictions, and social distancing mandates associated with the coronavirus pandemic will hurt The Estee Lauder Co. Inc.'s operating performance for the remainder of fiscal 2020 and into 2021."

On March 30, Moody's affirmed TJX Companies, Inc.'s ratings at A2 while revising its outlook to negative stating it "reflects the risk that the disruption caused by COVID-19 and weakening consumer demand along with the recent debt raise will lead to a sustained weakening of credit metrics. Financial policy is expected to remain conservative with any reinstatement of share repurchases or dividends only following a return to sales and operating income growth." Its ratings reflect "its leading position as the largest global off-price retailer of apparel and home goods, a segment of retailing that has outperformed many alternative channels in recent years. Moody's expects it "to continue to gain market share long term despite the near term significant disruption from COVID-19 and weakening consumer demand. The rating reflects the benefits of its leading position, its flexible supply chain and extensive vendor relationships."

On March 27, S&P's downgraded TJX Companies, Inc.'s ratings from A+ to A while revising its outlook to negative stating it reflects "our expectation that operating results will be significantly weaker than our previous projection, with leverage exceeding 2x in fiscal 2021 ending January 2021. The negative outlook reflects the risk for a lower rating if prolonged disruption to business operation and consumer spending causes us to reassess TJX's business or financial position."

On April 6, S&P's affirmed The Coca-Cola Co.'s ratings at A+ while revising its outlook to negative stating it "reflects the potential for a lower rating within the next 12 months if we forecast that the fallout from the coronavirus on the global economy and consumer behavior will prevent Coke from improving credit ratios by the end of 2021, including sustaining adjusted leverage below 3x. The Coca-Cola Co.'s (Coke) profitability will likely decline in the first half of 2020 due to the negative economic impact of the global coronavirus outbreak."

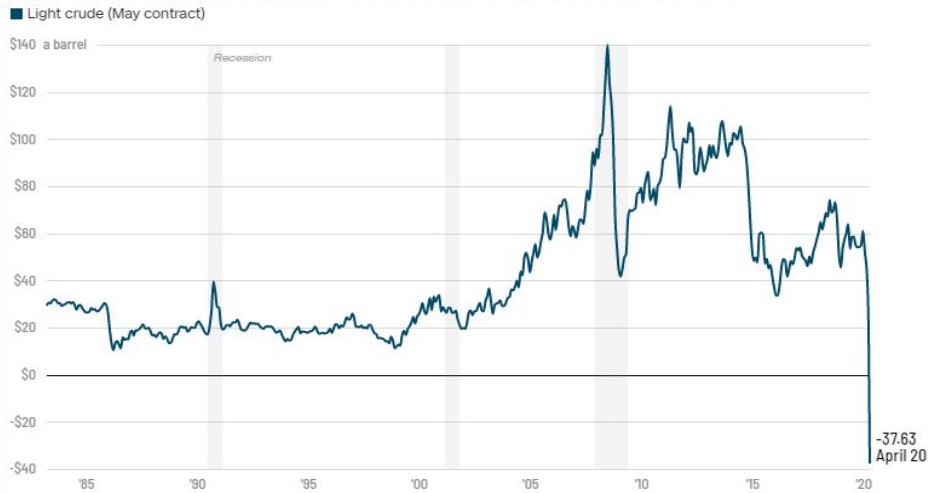
MARKET OUTLOOK

The Coronavirus outbreak continues with over 3 million confirmed cases and 200,000+ deaths worldwide, including over 970,000 cases and 50,000+ deaths in the US alone. Stay-at-home orders have impacted 95% of the US population. Business closures continue to impact the economy. In the past 5 weeks, over 26.5 million jobless claims have been filed. With declines in demand for fuel while supply continues to increase, crude oil hit negative territory at -\$37.63 a barrel on April 20. It has recovered since then with companies shutting production, but prices remain under pressure as worldwide crude storage reaches maximum capacity. Treasury yields continue to hover around record lows of ~0.38% for the 5 year and ~0.64% for the 10 year. It is expected that yields will continue to be range bound in the near future.

With the slowdown of the virus and expansion of testing, there have been some discussions to slowly lift restrictions and reopen certain businesses and public facilities. A Coronavirus vaccine could also be available as early as this year, faster than initially expected. The S&P 500 and Dow are now both up ~30% from the lows they hit in March. Despite some positive signs, there are still uncertainties around the long-term economic impact of the pandemic and how it may change business and consumer behavior in the foreseeable future. As we closely monitor the situation, we continue to maintain adequate liquidity levels and are well positioned for any adjustments as needed.

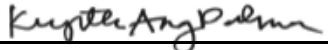

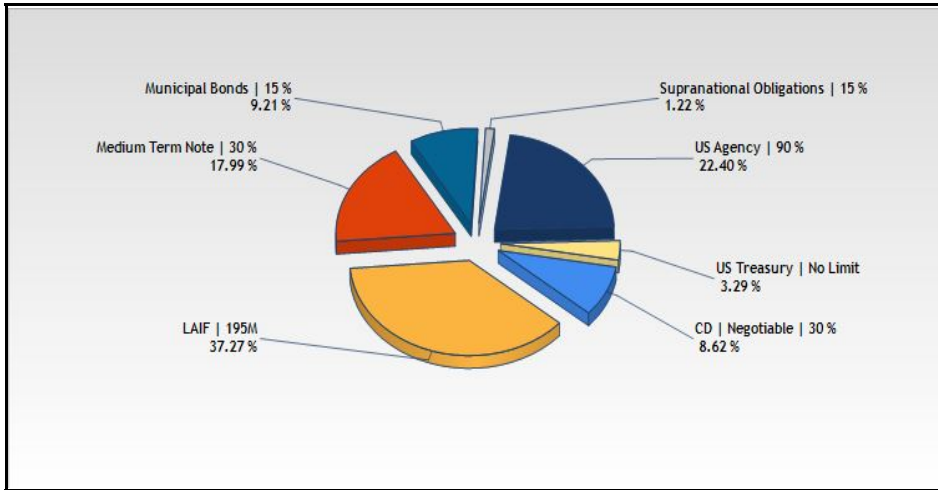
City of Burbank Distribution by Asset Category - Market Value Monthly Treasurer's Report

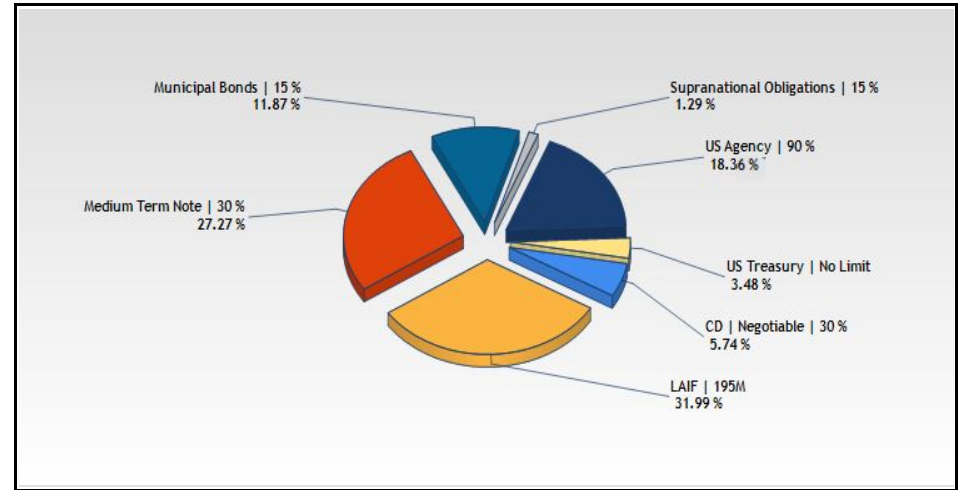

Portfolio Holdings as of 3/31/2020





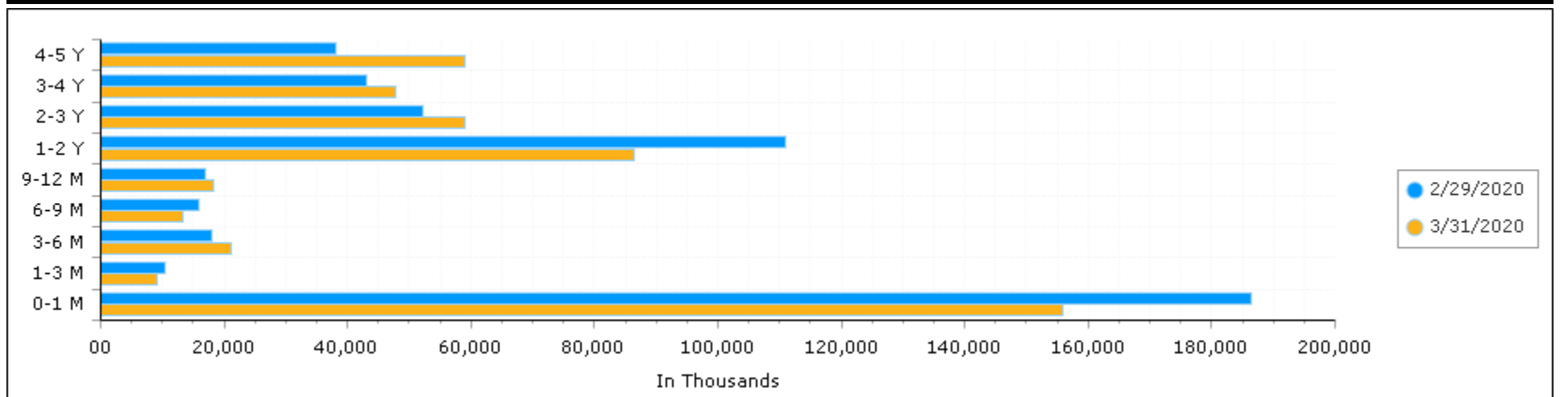

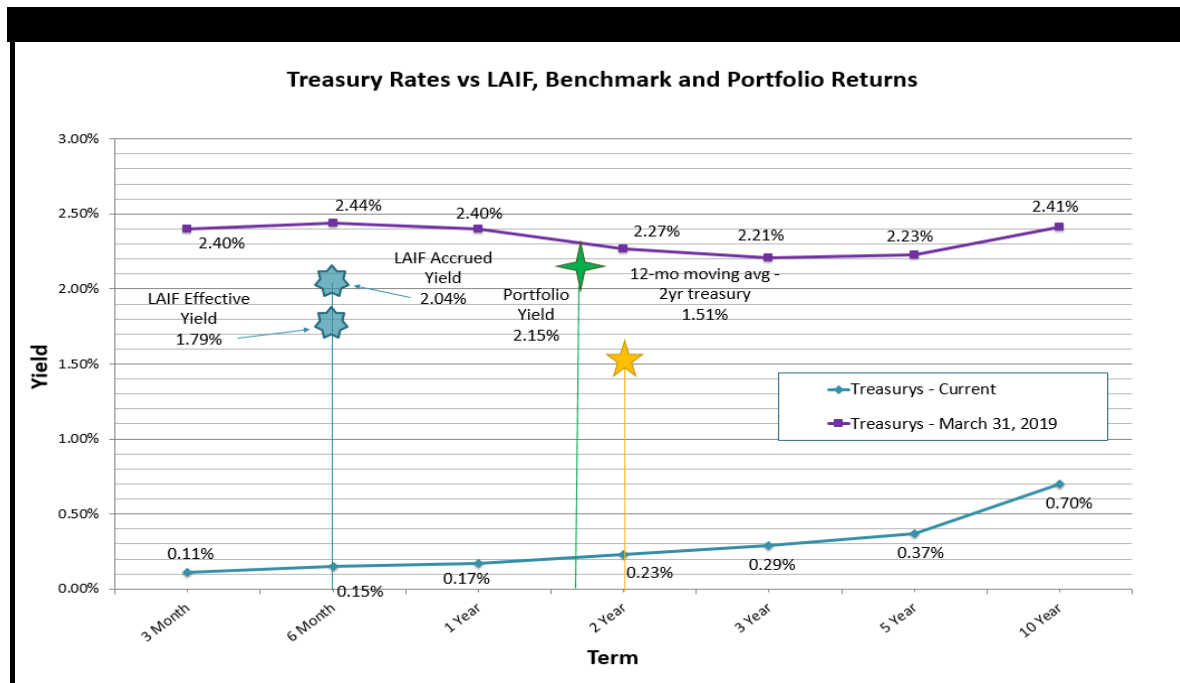

The chart to the left shows relevant rates (LAIF, the 12-month moving average of the 2-year treasury, and portfolio current yield) as March 31, 2020, as well as current treasury yields and those from a year ago.

NOTE: Estimates for the interest earned on LAIF's loan to CalPERS (not allocated until just after the end of each quarter) are included in this month's LAIF yield. The effective rate of return published by LAIF was 1.79%; including an estimate of the bonus accrual for the loan to CalPERS and the under accrual from January and February, the yield reflected on the books for March is 2.04%. The rate of interest charged by LAIF on the CalPERS loan is the Constant Maturity 2-Year Treasury as of the last day of the quarter.
