File if a contribution of \$1,000 or more in the aggregate is made to or in connection with <i>another</i> candidate or measure being voted upon on November 5, 2024. Committees that receive a non-monetary contribution of \$1,000 or more in the aggregate must file a Form 497 within 48 hours from the time the contribution is received. Must be filed electronically.
Sep 26, 2024 1 st Pre-Election	7/1/24 – 9/21/24	460 or 470	 Each candidate listed on the ballot must file Form 460 or Form 470 (see below). Form 460 must be filed electronically (see method of delivery below).
Oct 24, 2024 2 nd Pre-Election	9/22/24 – 10/19/24	<u>460</u>	 All committees must file this statement. Must be filed electronically.
Nov 1, 2024 3 rd Pre-Election	10/20/24 - 10/30/24	<u>460</u>	 All committees must file this statement by 5 p.m., Friday, November 1, 2024. Must be filed electronically.
Jan 31, 2025 Semi-Annual	10/31/24 – 12/31/24	<u>460</u>	 All committees must file Form 460 unless the committee filed termination Forms 410 and 460 before December 31, 2024. Must be filed electronically.

Additional Notes:

- *Period Covered: The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- Local Ordinance: Burbank Municipal Code (BMC) 2-3-206 requires an additional pre-election statement to be filed.
- **Deadline Extensions:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to a 24-hour/10-day Contribution Report (Form 497) that is due the weekend before the election, and this extension never applies to any 24-hour/10-day Independent Expenditure Report (Form 496). Such reports must be filed within 24 hours, regardless of the day of the week.
- **Method of Delivery:** BMC <u>2-3-204</u> requires electronic filing of campaign statements, reports, or other documents for any elected officer, candidate, or committee that has received contributions or made expenditures of \$2,000.00 or more via the City Clerk's online system.
- Form 501: All candidates must file Form 501 (Candidate Intention Statement) before soliciting/receiving contributions.

- Form 460: Candidates who have raised/spent \$2,000 or more file the Form 460. The Form 410 (Statement of Organization) must also be filed once \$2,000 or more has been raised/spent.
- Form 470 (2024): Candidates who do not raise or spend \$2,000 or more (or anticipate raising or spending \$2,000 or more) in 2024 and do not have an open committee may file Form 470 on or before September 26, 2024. If, later during the calendar year, the candidate raises or spends \$2,000 or more, a Form 470 Supplement and a Form 410 must be filed.
- Independent Expenditures: Committees making independent expenditures totaling \$1,000 or more to support or oppose other candidates or ballot measures also file:
 - Form 496: This form is due within 24 hours if made in the 90-day, 24-hour reporting period of the candidate's or measure's election. Refer to the applicable filing schedule. Form 496 is filed with the filing officer in the jurisdiction of the affected candidate or measure.
 - Form 462: This verification form must be e-mailed to the FPPC within 10 days.
- After the Election: Reporting requirements will depend on whether the candidate is successful and whether a campaign committee is open. See <u>Campaign</u>
 Disclosure Manual 2 for additional information.
- Public Documents: All statements and reports are public documents.
