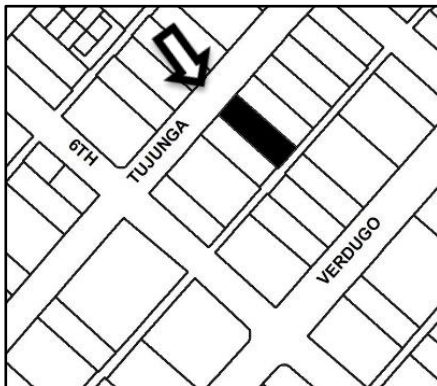


## Public Notice

The existing structure on site will be demolished. The project site is located in the R-4, High Density Residential Zone, and the General Plan land use designation is High Density Residential. This project has been determined to be exempt from the California Environmental Quality Act (CEQA) per Section 15303 – New Construction of New Structures. This exemption is applicable given that the project consists of a multi-family residential structure, totaling no more than six dwelling units.

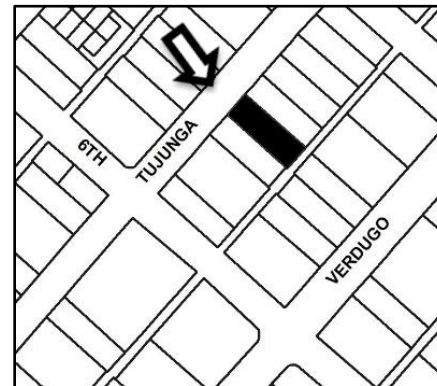
