Plaques are not installed for trees, instead, a keepsake certificate for the planting of the commemorative tree will be provided to the donor.

## BENCH OR TREE LOCATION PREFERENCE

Staff will do their best to accommodate requested location. However, staff may recommend an alternate placement based on park needs and availability.

Program documents will be maintained in the P&R Administration Office that contains a map of each park site and indicated potential sites for the location of commemorative trees and benches. Each previously sponsored tree and bench will also be highlighted on the map and in an associated database.

## OUR COMMITMENT

The Parks and Recreation Department will have the bench installed within 100 days of receipt of the donation. \* The bench will be guaranteed for 10 years after the date of installation. If a tree or bench is damaged within the 10-year period, it will be replaced. Tree plantings are guaranteed and will be replaced if damaged. The maintenance of the benches will be the responsibility of the P&R Department. Maintenance (Graffiti removal, sanding/staining, and periodic cleaning) will be provided by the P&R Department for the life of the bench (at Department's discretion).

There is a ten-year (10) guarantee of bench maintenance and plaque replacement. The bench will be kept in place as long as it is serviceable beyond the 10-year period. When a bench is no longer serviceable, applicants will be advised and given the opportunity to purchase a new bench under the terms and conditions in effect.
